Storage instructions

Store Aermoney RespiClick™ at room temperature (between 15 °C and 25 °C) in a dry place; excursions permitted from 15 °C to 30 °C. Avoid exposure to extreme heat, cold, or humidity. Aermoney RespiClick™ should be stored inside the unopened moisture-protective foil pouch and only removed from the pouch immediately before initial use. Discard Aermoney RespiClick™ 30 days after opening the foil pouch or when the counter reads "0," whichever comes first. The inhaler is not reusable. Do not attempt to take the inhaler apart.

Keep out of reach of children.

Aermoney RespiClick™ is indicated for the maintenance treatment of steroid-responsive bronchial asthma as prophylactic therapy in patients 12 years of age and older.

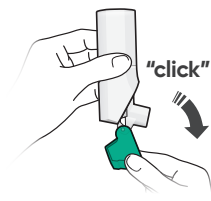

To use: Open. Inhale. Close.

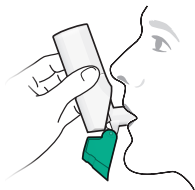
Open.

OPEN the cap all the way until you feel and hear
a "click"—once the cap clicks, one dose is ready to
be inhaled.

Make sure you are holding the inhaler upright.
Before going to step 2, hold the inhaler away from your
mouth and breathe out through your mouth as much air
as you can and as is comfortable.

- **Never breathe out into the inhaler mouthpiece.**
- **Do not open the green cap unless you are taking a dose.**

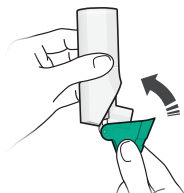
Inhale.

INHALE quickly and deeply through the mouth, until lungs feel completely full of air.

Your lips should form a good seal around the mouthpiece, but the vent above the mouthpiece should not be blocked by the lips or fingers. Remove the inhaler from your mouth and hold your breath for about 10 seconds or for as long as you comfortably can.

- **Do not take an extra dose from the inhaler even if you do not taste or feel the medicine.**

Close.

CLOSE the cap after inhaling so that the inhaler will be ready for the next dose.

Rinse your mouth with water after taking your dose.
Spit out the water. Do not swallow it.

Throw away your inhaler 30 days after you have opened the foil pouch or when the counter reads "0," whichever comes first.
