**SUBJECT: Information notice - Sandoz divestment of the following products to Odan in Canada**

PrSandoz® Indomethacin

PrSandoz® Prochlorperazine (Together, "the Products")

By Sandoz Canada Inc. ("Sandoz") to Odan Laboratories Ltd. ("Odan")

Dear Customer,

Sandoz wishes to inform you that on March 1, 2023, Sandoz and Odan entered into an asset purchase agreement whereby Sandoz is divesting PrSandoz® Indomethacin and PrSandoz® Prochlorperazine to Odan. This agreement includes DINs but **excludes** Sandoz current available inventories. Odan is a Canadian specialty pharmaceutical company, headquartered in Montreal, with fully integrated infrastructures for R&D, manufacturing and distribution and a market leader for suppositories.

Due to production constraints at the current manufacturing plant, following the acquisition, Odan will begin the site transfer process to its facility in Montreal. This will cause a temporary supply disruption of the products for several months (see table below for more information.) Rest assured that Sandoz and Odan are working closely together to bring the products back on the market as soon as possible.

Effective as of **October 31, 2023**, Odan will handle ordering, billing, shipping and returns relating to the Products. Prior to that date, Sandoz will remain responsible for all functions, including returns of the Products.

Sandoz terms and conditions will apply to all orders fulfilled by Sandoz. Effective October 31, 2023 all sales of the Products will be governed by Odan's terms and conditions.
